CONSENT ORDER

Deputy Eastwood
Before District Judge sitting in Chambers at Liverpool County Court, 35 Vernon Street, Liverpool, L2 2BX on *10 March* 2011 without attendance of the parties and upon reading a draft of this consent order signed by each party's solicitor and the parties having agreed to the terms set out hereto and in the attached schedule

IT IS ORDERED BY CONSENT:

1. The Defendant shall pay £6,400 to the Claimants solicitors by sixty four bank standing order payments of £100 monthly paid on the 1st day of each calendar month commencing 1st April 2011 comprising:
 - a) £400 to the Claimants by way of Damages
 - b) £6,000 in full settlement of the Claimants legal costs, vat thereon and disbursements
2. The Defendant shall no later than 15th April 2011 publish an apology in the next edition of Liberal Democrat "Focus" or newsletter whichever is the sooner and deliver the same to no less than 5000 households within the Liverpool St. Michaels council ward
3. The said apology shall be headed "Apology to Green Party Councillors" and shall read: "In February 2009 we published an article under the heading "Green Councillors Make Homeless Sleep in The Snow". We accept that this was inaccurately reported and factually incorrect. We regret any distress or embarrassment that the article caused to Councillors Sarah Jennings and John Coyne"
4. The apology referred to in paragraph 2 of the Order and the heading thereto shall be printed using the same type, colour and font sizes used by the Defendant when he published an article in February 2009 headed "Green Councillors Make Homeless Sleep in The Snow"
5. That all further proceedings in this claim be stayed except for the purpose of enforcing this Order and/or the terms set out in the Schedule below

6. That either Party may apply to the court to enforce this Order and/or the terms set out in the Schedule below without the need to commence new proceedings


SCHEDULE

1. Upon completion of the sale (or re-mortgage) of the property known as 15 Guernsey Road, Liverpool, L13 6RN (registered at HM Land Registry under title number MS297027) the Defendant shall pay to the Claimants solicitors out of 50% of the proceeds of sale or re-mortgage thereof (after deduction of conveyancing fees, any estate agents commission and redemption of the Legal Charge thereon dated 15th December 2006) a sum of money that is equal to the unpaid balance of monies to be paid pursuant to clause 1 of the above Order
2. Until such time that the monies ordered to be paid pursuant to the above Order have been paid in full the Defendant shall send to the Claimants solicitors on each anniversary of the date of this Order a statement of his monthly income and expenditure and, if requested, documentary evidence thereof and there shall be liberty for the Claimant to apply to court to increase the monthly payments paid by the Defendant
3. Upon payment of the sums agreed and costs ordered to be paid, and upon compliance with the terms of this Schedule the parties' respective liabilities, each in respect of the other, shall be discharged.
